## CMA PROGRAM REQUIREMENTS:

- To be eligible to apply for the CMA designation, candidates must successfully complete a Master's Program in accordance with the completion requirements set by the University. Candidates must achieve a minimum grade of 60% on each CMA required course. All accredited combined programs Candidates must achieve a minimum grade of 60% on each CMA required course and a 75% overall average on the CMA required courses. Please refer to the combined CMA master's program candidate handbook for a list of accredited programs and requirements.
- All candidates interested in pursuing the CMA designation through this combined program, must apply to the Certified Management Accountants of Ontario and enrol in the components within 13 months of completion of graduate studies.
- Candidates will have five years upon entering graduate studies to complete the CMA Accelerated Program, Entrance Exam, Case Exam and the Board Report component requirements as well as the Practical Experience Requirement.
- Candidates at the end of the Master's Program will be required to enroll and successfully complete the CMA Components below:

Note: Candidates must complete the CMA Accelerated Program as determined by the Certified Management Accountants of Ontario based on the evaluation of the candidate's transcript. Candidates from any full time studies, part-time program (where applicable) and/or co-op program will be required to complete Business Application Reports prior the end of their co-op term or program studies.

Next steps are to:

1. Enroll in the first available offering of the CMA Accelerated Program after completing Master's studies (deferrals will be granted on an exception basis upon application).
  2. Achieve 60% or higher on the CMA Accelerated Program to be eligible for the Entrance Examination
  3. Achieve 60% or higher on the CMA Entrance Examination and CMA Case Examination
  4. Achieve 60% or higher in the nationally administered CMA Board Report process
- In the event that candidates are not successful on the CMA Accelerated Program, they will be required to re-attempt the Accelerated Program on the next available offering.
  - In the event that candidates are not successful on the CMA Entrance Examination or the CMA Case Examination, they will be required to rewrite the Examination(s) within 13 months of the last attempt. Both examinations are offered twice per year.
  - In the event that candidates are not successful on the CMA Board Report, they will be required to re-attempt the Board Report on the next available offering. The Board Report is offered once per year.
  - Candidates are only allowed 3 attempts each on the Entrance Examination, Case Examination and Board Report.
  - The Board Report process commences in January each year.

## PRACTICAL EXPERIENCE REQUIREMENTS:

The practical experience requirement is 24 months of full-time experience within the domain of management accounting achieved at the Career Stage 2 – Basic Proficiency level, with 12 months concurrent with the MBA and/or CMA programs. A practical experience report must be submitted to CMA Ontario as part of the application process; candidates will not be enrolled into any CMA component without completion of this report.

Note: The \$565 registration fee is required with submission of this application. To participate in the 2010-2011 Board Report Process or May Case Exam, applications are due by January 27, 2011. If required to complete the Accelerated Program and/or Entrance Exam, candidates must first successfully complete these components prior to registering in the Case Exam and/or Board Report.

If the component payment option is chosen then, candidates must submit an application and the required fee upon registration. Program fees cover the first attempt of the CMA Accelerated Program, Entrance Examination, Case Examination, Board Report, a Preparation Course for the Case Examination & Board Report and two years of CMA membership fees while in the program. Rewrite fees apply for any program component and the Combined Master's Program component fees are subject to change.

Cancellation requests are subject to the notification deadlines and administrative fees of each component as outlined on the component application. Payment by either cheque or credit card is acceptable. If paying by cheque, please mail the cheque, payable to Certified Management Accountants of Ontario, along with this form to the address on the front of this application. If paying by credit card, you may submit the payment option form by fax to 416-977-2128 or by mail to the address on the front of this application.
