### ALTERNATE CHANNEL PROGRAMS:

#### COMBINED PROGRAMS:

Required components vary depending on the specific program. The Entrance Exam Preparation Program is required for Combined Program students either via distance or lecture (as space permits). The fees for the Combined Master's Program can be paid in full or upon registration into each component as per the table below:

<b>Registration Fee</b>	\$500 + \$65 HST = \$565
<i>Registration fee is due upon registration and covers two years of CMA membership fees, after which candidates are required to remit the annual candidate membership fee</i>	
<b>Accelerated Program</b>	\$1500 + \$195 HST = \$1695
