### **PST-Harmonization – Update on How it Will Affect Your Organization**

Organizations with operations in Ontario will be affected by the Province's plan to harmonize its provincial sales tax with the federal GST. Though most Ontario industries will benefit, some may face an extra tax or administrative burdens. Most entities will also need to adjust their accounting systems and operations to prepare for the change.

Jane Adams, FCMA is an Associate Partner with KPMG's Indirect Tax practice and will update us on the effects of PST-GST harmonization on different industries. Jane will address more of the impacts such as the transitional rules, new point of sale rebates and compliance matters.
