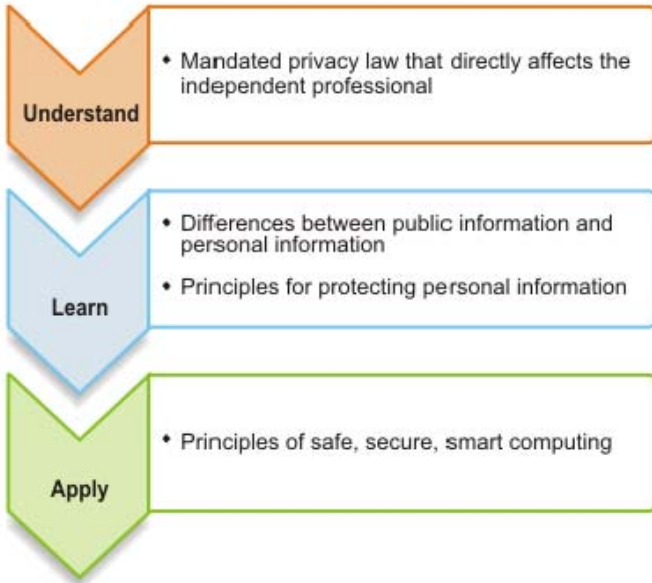




Safe Computing for the Management Accountant Are you putting your time, business and reputation at risk?™
